The interviewers will want to discuss the nature and range of consultancy services you offer so please ensure that your attached CV shows this. They may ask you to talk them through some recent consulting assignments and it will be helpful if you can supply details one or two assignments, if your CV does not already give sufficient detail.

If you are accepted you will be expected to:

- pay the appropriate membership fee for the remainder of the current year (subscription year commences on 1 January)
- pay any one-off admission fee applying (see step-by-step guide)
